Customer, at customer's sole expense, shall provide CSP a certificate of insurance coverage certifying the existence of general liability insurance coverage.</p>	<p>ITEM 220</p> <p align="center">SWITCHING TO AND FROM STORAGE/HOLD TRACKS</p> <p>Charges shown below will be assessed per car for cars switched into and out of storage. The charges will be assessed in each direction.</p> <p align="center">(a) Non-Hazardous Cars..... \$500.00 (b) Hazardous Cars..... \$650.00</p>
<p>ITEM 210</p> <p align="center">STORAGE HOLD CHARGES ON PRIVATE CARS AND FOREIGN LOCOMOTIVES (See Note)</p> <p align="center">I - PRIVATE CARS</p> <p>Private cars, loaded or empty, held on CSP storage/hold tracks at customer request, will be subject to a storage hold charges per car per day, or fraction thereof, as shown below, computed from the time car is first held until car is released from storage hold:</p> <p align="center">(a) Non-Hazardous Cars..... \$20.00 (b) Hazardous Cars..... \$25.00</p> <p align="center">II - FOREIGN LOCOMOTIVES</p> <p>Foreign Locomotives held on CSP storage/hold tracks awaiting disposition instructions will be subject to a storage hold charge of \$500.00 per locomotive per day, or fraction thereof, computed from the time locomotive is first held until locomotive is released from storage hold.</p> <p>Note: This railroad does not assume liability beyond reasonable and ordinary care while cars or locomotives are stored/held on storage/hold tracks of this railroad, or for loss or damage caused by an Act of God, vandalism or theft. In the event full liability coverage is desired, cost of such coverage will be the responsibility of the customer or owner.</p>	<p>ITEM 230</p> <p align="center">REPOSITIONING CARS</p> <p>When a customer requests removal of specific car(s) from storage which requires this railroad to sort and reposition other cars at the customer's request, a charge of \$500.00 per car, per occurrence, will be assessed to the customer making the request. These charges are in addition to the outbound switch charge.</p>
