<p><b>ITEM 10</b></p> <p align="center"><b>METHOD OF CANCELING ITEMS</b></p> <p>As this tariff is supplemented, numbered items with letter suffixes cancel corresponding numbered items in the original tariff or in a prior supplement. Letter suffixes will be used in alphabetical sequence starting with A.</p> <p>Example: Item 100-A cancels Item 100 and Item 300-B cancels Item 300-A in a prior supplement which in turn canceled Item 300.</p>	<p><b>ITEM 200</b></p> <p align="center"><b>IMPROPER CARS FURNISHED FOR LOADING BY CONNECTING LINES</b></p> <p>When cars ordered by industries for loading are refused by the LKRR or its customers on account of not being in proper condition to load and subsequently returned to the furnishing railroad, a switch charge of \$199.00 per car will be assessed against railroad furnishing such cars.</p>
