<p align="center"><b>RULES AND OTHER GOVERNING PROVISIONS RULES AND REGULATIONS—GENERAL</b></p>	<p align="center"><b>SECTION 1 CAR DEMURRAGE RULES AND CHARGES</b></p>
<p><b>ITEM 5</b></p> <p align="center"><b>METHOD OF CANCELLING ITEMS</b></p> <p>As this tariff is supplemented, numbered items with letter suffixes cancel corresponding numbered items in the original tariff, or in prior supplements. Letter suffixes will be used in alphabetical sequence starting with A. Example: Item 300 - B cancels Item 300 - A in a prior supplement which, it turn, cancelled original Item 300.</p>	<p><b>ITEM 130</b></p> <p align="center"><b>DEMURRAGE CHARGES</b></p> <p>After expiration of free time allowed, a charge of \$45.00 per car per day, or fraction of a day, will be made until car is released.</p> <p>The applicable charge will accrue on all Saturdays, Sundays and holidays subsequent to the first chargeable day, including a Saturday, Sunday or holiday immediately following the day on which the first chargeable day begins to run.</p> <p>Note 1: Not applicable on privately-owned cars on private tracks.</p> <p>Note 2: Privately-owned cars which are first held on railroad tracks will be subject to demurrage charges provided for herein after expiration of free time (See Item 120) until such time car is placed on private tracks.</p>
<p align="center"><b>SECTION 1 CAR DEMURRAGE RULES AND CHARGES</b></p>	<p align="center"><b>SECTION 2 STORAGE RULES AND CHARGES</b></p>
<p><b>ITEM 100</b></p> <p align="center"><b>APPLICATION</b></p> <p>Except where provided to the contrary, Demurrage Rules and Charges contained herein apply to all railroad and privately owned or leased cars held for or by consignor and consignee for any purpose.</p>	<p><b>ITEM 200</b></p> <p align="center"><b>STORAGE/HOLD CHARGE</b></p> <p>Cars, loaded or empty, held on storage/hold tracks of the MGRI at the request of receiver or consignee, will be subject to storage/hold charge of \$35.00 per car per day, or fraction of a day, computed from time car is first held until car is released from storage/hold track.</p>
<p><b>ITEM 110</b></p> <p align="center"><b>HOLIDAYS</b></p> <p>Wherever reference is made to "holidays," it shall mean only the days listed below:</p> <p>New Year's Day - January 1 (See Note 1)          Washington's Birthday -Third Monday of February          Memorial Day - Last Monday of May          Independence Day - July 4 (See Note 1)          Labor Day - First Monday of September          Thanksgiving Day -Fourth Thursday of November          Christmas Day - December 25 (See Note 1)</p> <p>Note 1 - When this date occurs on a Sunday, the following Monday will be observed as the holiday.</p>	<p><b>ITEM 205</b></p> <p align="center"><b>SWITCHING TO AND FROM STORAGE/HOLD TRACKS</b></p> <p>The MGRI will assess a charge of \$100.00 per car for moving cars into and out of storage. The charge will apply in each direction.</p>
<p><b>ITEM 120</b></p> <p align="center"><b>FREE TIME</b></p> <p>Free time as follows will be allowed for each car:</p> <p>Seventy-two (72) hours to complete loading.</p> <p>Seventy-two (72) hours to complete unloading.</p> <p>Free time will be computed from time car is received on interchange. For the purpose of computing free time, Saturdays, Sundays and holidays will be excluded.</p>
