Charge for this service will be assessed against the carrier delivering the cars to PGR. Bad order cars set out on PGR tracks for repair by foreign carrier's repair crews will be considered cars without proper forwarding paperwork for the purpose of this item.</p> <p>When empty or loaded cars are received from a foreign carrier at the incorrect station and PGR physically handles the cars for whatever reason, a charge of \$440.00 per car will be assessed against the carrier delivering the cars to PGR.</p> <p>PGR shall not be liable for any setback, switching, or linehaul charges assessed another carrier resulting from billing errors by a customer or by a carrier which is not affiliated with PGR.</p>

**SURCHARGE ON BRUNK RESIN CARS**

A surcharge of \$935.00 shall apply on all Brunk Resin loaded railcars with an origin or destination of Brunk, LLC [or affiliated companies].

Surcharge shall apply on Progressive Rail's traffic interchanged with the Canadian Pacific Railway at Nesbitt, MN. Surcharge to be collected by and paid by Brunk, LLC , and accrue solely to the PGR.

All charges due - NET 30 days.
