GENERAL RULES AND REGULATIONS ITEM 10 PARTICIPATING CARRIER ABBREVIATION: NAME OF CARRIER: PGR PROGRESSIVE RAIL INC. ITEM 20 REFERENCE TO TARIFFS, ITEMS, NOTES, RULES, ETC. Where reference is made in this tariff to tariffs, items, notes, rules, circulars, etc., such references are continuous and include supplements to and successive issues of such tariffs, and reissues of such items, notes, rules, circulars, etc. ITEM 30	ITEM 100 APPLICATION OF FUEL SURCHARGE The provisions in this tariff will be in effect whenever the monthly Midwest Average On-Highway Diesel Price equals or exceeds the price per gallon listed in the first fuel price line of the Fuel Surcharge Table shown in Item 130. The monthly average will be calculated by totaling the Midwest Average On-Highway Diesel Price as provided by the U.S. DOE (See Note 1) for each week in a calendar month and dividing by the total number of weeks as provided by the U.S. DOE for said calendar month. The fuel surcharge as described in this tariff is applicable to the charges for accessorial services provided for by PGR in connection with rail – truck transfer services performed by PGR as described in Freight Tariff PGR 9300 – series. Tariffs, contracts, or quotations subject by reference to this tariff are hereby, or will on their effective dates, be increased as described in Item 130, for the period this tariff
METHOD OF CANCELLING ITEMS As this tariff is supplemented, numbered items with lettered suffixes cancel correspondingly numbered items in the original tariff or in a prior supplement. Letter suffixes will be used in alphabetical sequences starting with A. For example: Item 100-A cancels Item 100 and Item 200-B cancels Item 200-A in a prior supplement, which in turn cancelled Item 200.	is in effect. The fuel surcharge will be assessed to the party to pay the original base freight charge. The second calendar month prior to the current month will be the basis for determining the applicable fuel surcharge as shown in the Fuel Surcharge Table shown in Item 130. The fuel surcharge will apply to accessorial services performed on the 1 st day or after of the current calendar month. For Example: The monthly Midwest Average On- Highway Diesel Price as calculated in January will be used to determine the applicable fuel surcharge in March. Note 1- The current On-Highway Diesel Price may be obtained on the Internet at: <u>http://tonto.eia.doe.gov/oog/</u> info/gdu/gasdiesel.asp ITEM 120 DISPOSITION OF FRACTIONS Fractions of less than one-half cent resulting from the application of the percentage fuel surcharge to accessorial charges will be dropped; fractions of one-half cent or greater will be increased to the next whole cent.
