Buffer cars must meet the following requirements:</p> <ul style="list-style-type: none"> • Must be a boxcar, covered hopper, gondola or tank car. The buffer cannot be a flat car. • Must have a high-strength coupler (Grade E Coupler). • The length of the car must be at least 45 feet and not greater than 75 feet. • Must be loaded with a non-hazardous inert material that does not shift in train service. • Gross weight of car must be a minimum of 45 tons. • It is the responsibility of the Customer to provide buffer cars that are in good mechanical condition. If a car fails inspection, this railroad retains the right to refuse to provide train service.
