<p>ITEM 100-G</p> <p align="center">SWITCHING RATES, SERVICES AND CHARGES</p> <p align="center">PART A - RICHLAND BRANCH</p> <p align="center">APPLICATION</p> <p>Switching rates herein to and from the Interchange point, at Richland Junction (Station 201) to points North on the TCRY rail line, cover the handling of cars loaded in one direction. If cars are loaded in both directions, regular switching charge per car will be made for each loaded movement.</p> <p align="center">CHARGES</p> <p>Applicable for Interchanges that occur at the South end of the TCRY interchange at Richland Jct. (Station 00200) and 00201 (excluding placarded rail cars containing hazardous material):</p> <ol style="list-style-type: none"> (1) Cars, except refrigerated cars used for frozen potatoes/vegetables, placed, spotted or pulled from industries located South of TCRY primary train yard at Station 00400.....\$375.00 (2) Refrigerated cars used for frozen potatoes/vegetables, zero to 5000 interior cubic feet, placed, spotted or pulled from industries located South of TCRY primary yard at Station 00400.....[I]\$375.00 (3) Refrigerated cars used for frozen potatoes/vegetables, 5001 to 6500 interior cubic feet, placed, spotted or pulled from industries located South of TCRY primary yard at Station 00400.....[I]\$450.00 (4) Refrigerated cars used for frozen potatoes/vegetables, 6500 interior cubic feet and over, placed, spotted or pulled from industries located South of TCRY primary yard at Station 00400.....\$525.00 (5) Cars placed, spotted or pulled from industries North of the TCRY Station 00300 (primary train yard) to Station 00500.....\$550.00 (6) Cars placed, spotted or pulled from industries North of the TCRY Station 00500.....\$675.00 (7) Locomotives placed, spotted or pulled from industries located at or South of TCRY Station 00500.....\$900.00 per locomotive (8) Ascetic anhydride in shipper owned or leased tank cars.....\$500.00 (9) Liquid caustic soda in shipper owned or leased tank cars.....\$500.00 <p>Switching charges of \$1,500.00 per car shall apply on all cars placed, spotted, or pulled which are placarded as containing radioactive hazardous materials and/or waste. Station 00201\$100.00</p> <p>Cars or locomotives delivered, placed, spotted, or pulled past the designated TCRY Interchange at Richland Jct. Station 00201 by any railroad carrier over the TCRY mainline (other than TCRC and its employees) to stations North, to and including Station 00500.....\$1000.00</p> <p>Cars or locomotives delivered, placed, spotted, or pulled past the designated TCRY Interchange at Richland Jct. Station 00201 by any railroad carrier over the TCRY mainline (other than TCRY and its employees) to stations North of Station 00500\$5000.00</p> <p>Additional charges of 20% (twenty-percent) apply to all unpaid charges for services not paid within 30 (thirty) days of services provided.</p> <p>Additional charges of 40% (forty-percent) apply to all unpaid charges for services not paid within 60 (sixty) days of services provided.</p> <p>Additional charges of 40% (forty-percent) apply to all unpaid charges for services not paid within 90 (ninety) days of services provided.</p> <p align="center">PART B - OLYMPIA BRANCH</p> <p align="center">APPLICATION</p> <p>Switching rates herein to and from the Interchange point, at Olympia, WA (Station 900) cover the handling of cars loaded in one direction. If cars are loaded in both directions, regular switching charge per car will be made for each loaded movement.</p> <p align="center">CHARGES</p> <p>Applicable on Interchanges that occur at Olympia, WA (Station 900).</p> <p>Prior to shipment and/or delivery, contact the TCRY to request switching charge rates on all rail shipments originating or terminating at industries located on TCRY rail line at Olympia. Switching rates will be provided by TCRY in either letter authority or electronic format.</p> <p>In the case where railcars are interchanged to TCRY without prior rate authority provided, TCRY may provide the switching service and charge the standard TCRY default rate of \$375.00.</p>
