# STATION LISTS AND CONDITIONS

This publication is governed by the Official Railroad Station List, OPSL 6000 -series, issued by RAILINC, Agent.

# REFERENCE TO TARIFFS, ITEMS, NOTES, RULES, ETC.

Where reference is made in this tariff to tariffs, items, notes, rules, etc., such references are continuous and include supplements to and successive issues of such tariffs, and reissues of such items, notes, rules, etc.

#### **ITEM 30**

## **METHOD OF CANCELLING ITEMS**

As this tariff is supplemented, numbered items with lettered suffixes cancel correspondingly numbered items in the original tariff or in a prior supplement. Letter suffixes will be used in alphabetical sequences starting with A. For example: Item 100-A cancels Item 100 and Item 200-B cancels Item 200-A in a prior supplement, which in turn cancelled Item 200.

# RULES AND OTHER GOVERNING PROVISIONS RULES AND REGULATIONS-UNLIMITED

#### ITEM 75

# **CARS HELD FOR PAYMENT**

Cars held for payment of freight or accessorial charges shall accrue demurrage charges at the same rate as normal demurrage charges. However no free time shall be granted.

# **ITEM 80**

# CARS HELD FOR SHIPPING INSTRUCTIONS

Cars held for shipping instructions will accrue demurrage charges at the same rate as normal demurrage charges. However no free time shall be granted.

# ITEM 90

# CARS HELD FOR LOAD ADJUSTMENT

Cars held for the adjustment of lading will accrue demurrage charges at the same rate as normal demurrage charges. However, no free time shall be granted.

# SECTION 1 DEMURRAGE RULES AND CHARGE

## **ITEM 100**

# CARS SUBJECT TO DEMURRAGE RULES AND CHARGES

Railroad, railroad controlled, and private cars held for or by consignees and consignors for any purpose are subject to the demurrage rules and charges described in this tariff. All cars of TTX Company will be considered railroad controlled equipment.

Exception - Demurrage rules and charges contained herein will not apply to empty or loaded private cars held on private tracks.

## **ITEM 110**

## **HOLIDAYS**

Wherever reference is made to "holidays," it shall mean only the days listed below:

New Year's Day - January 1 (See Note)
Memorial Day - Last Monday of May
US Independence Day - July 4 (See Note)
Labor Day - First Monday of September
Thanksgiving Day - Fourth Thursday of November
Christmas Day - December 25 (See Note)
New Year's Eve - December 31 (See Note)

Note 1 - When this date occurs on a Saturday or Sunday, the following Monday will be observed as the holiday.

# **FREE TIME**

Free time will be allowed for each car as follows:

- Three business days from the first midnight following actual or constructive placement.
- Holidays as listed in Item 110, provided that a chargeable day has not occurred prior to the holiday.
- Saturdays and Sundays, provided that a chargeable day has not occurred prior to the Saturday or Sunday.

# **CHARGEABLE DAYS**

Chargeable days are defined as days that follow the expiration of free time as described in Item 120.
