Customer, at customer's sole expense, shall provide WN a certificate of insurance coverage certifying the existence of general liability insurance coverage.</p>	<p>ITEM 220 [I]</p> <p style="text-align: center;">SWITCHING TO AND FROM STORAGE/HOLD TRACKS</p> <p>Charges shown below will be assessed per car for cars switched into and out of storage.
